DETERMINATION NO. 14 OF 2010

SALARIES — AMENDMENT

The Defence Force Remuneration Tribunal makes the following Determination under section 58H of the *Defence Act 1903*.

Commencement

1. This Determination commences on the day of signature.

Amendment

2. Determination No. 15 of 2008, Salaries, as amended, is amended as set out in this Determination.

Clause A.1.9 (Salary of member of the Reserve Forces)

3. Omit

B.2.5 (Rate of salary on advancement from Other Rank – other situations)

4. Insert at the end:

“B.2.6 Discounted rate of salary for certain Reserve Force officers

1. This clause applies to an officer of the Army Reserve Force who holds the rank of Brigadier or below and who meets the following conditions:

(a) the officer does not hold the professional competencies to be deployed in his or her employment category; and

(b) the officer is not a specialist officer; and

(c) in the last five years, the officer has not served in either of:

(i) the High Readiness Reserve; or

(ii) the Permanent Force.

2. The rate of salary payable to the officer under sub clause B.2.6.1 is the rate for the officer’s rank and increment in Part 3 of Schedule B.3.”

7. Omit Part 3 of Schedule B.4.

Schedule B.10 (Warrant Officer Class 1 salary rates), Part 3

8. Substitute title only:

“Warrant Officer Class 1 of the Reserve Force”

Schedule B.10 (Warrant Officer Class 1 salary rates), Part 4

9. Omit Part 4 of Schedule B.10.

Schedule B.12 (Other Rank salary rates), Part 2

10. Substitute title only:

“Member of the Reserve Force”

Schedule B.12 (Other Rank salary rates), Part 3

11. Omit Part 3 of Schedule B.12.

Schedule B.14 (Specialist Officer - Aviation), Part 2


12. Substitute title only:
