DETERMINATION NO. 6 OF 2012

SPECIAL OPERATIONS ENGINEER REGIMENT – AMENDMENT

The Defence Force Remuneration Tribunal makes the following Determination under section 58H of the *Defence Act 1903*.

PART A - Preliminary

Commencement

1. This Determination commences on the date of signature.

Amendment

- 2.1 Determination No. 5 of 2008, Special Forces Disability Allowance, as amended, is amended as set out in Part B of this Determination.
- 2.2 Determination No. 15 of 2008, Salaries, as amended, is amended as set out in Part C of this Determination.

PART B – Amendment of Determination No. 5 of 2008, Special Forces Disability Allowance

Clause 11 (Member of the Incident Response Regiment)

3. Delete clause 11 in its entirety and insert:

"11 Member of the Special Operations Engineer Regiment

A member who performs continuous full-time service in a designated position in the Special Operations Engineer Regiment is to be paid the allowance at the rate listed in column 4 or 5 for the member's position under Schedule 1."

Clause 12 (Reserve member supplementing the Incident Response Regiment)

4. Delete clause 12 in its entirety and insert:

"12 Reserve member supplementing the Special Operations Engineer Regiment

A member of the Reserve Forces who is used to supplement the Special Operations Engineer Regiment on an exercise or operation is to be paid the allowance at the daily rate listed in column 5 for the member's position under Schedule 1."

Schedule 1 (Allowance Rates)

5. Delete the Schedule 1 in its entirety and insert the schedule attached to this Determination.

PART C – Amendment of Determination No. 15 of 2008, Salaries

Subclause B.4.3.5 (Pay grade for a Warrant Officer Class 1)

- 6. Delete subclause B.4.3.5 in its entirety and insert:
- "5. If a member of the Army is in a Special Forces capacity listed in the following table, then the member's pay grade is increased by the number listed in column 3, up to the maximum pay grade listed in column 4.

- 8.2. To avoid doubt, a decision made in relation to the eligibility of a member before this Determination commenced is taken to continue to be effective in relation to that member as if the member met the eligibility condition as amended by this Determination.
