 - a. The rate of salary that was payable to them under one of the following of DFRT Determination No. 2 of 2017, *Salaries*, as amended by DFRT Determination No. 4 of 2021, *ADF Workplace Remuneration Arrangement 2020-2023*.
 - i. If the member is in the Permanent Force — Schedule B.13 Part 1 table item 1.
 - ii. If the member is in the Reserves — Schedule B.13 Part 2 table item 1.
 - b. Trainee allowance payable under Schedule B.1 of DFRT Determination No. 11 of 2013, *ADF allowances*, as amended by DFRT Determination No. 4 of 2021, *ADF Workplace Remuneration Arrangement 2020-2023*.
3. This section ceases to apply on the day the member completes basic recruit training.

EXPLANATORY STATEMENT

Defence Force Remuneration Tribunal No. 5 of 2021, Salaries and ADF allowances – Military Salary – Amendments

This Determination amends Defence Force Remuneration Tribunal (DFRT) Determination No. 2 of 2017, *Salaries* (the Salaries Determination), and Defence Force Remuneration Tribunal Determination No. 11 of 2013, *ADF allowances* (the Allowances Determination) made under section 58H of the *Defence Act 1903* (the Act) and in accordance with subsection 33(3) of the *Acts Interpretation Act 1901* (AIA Act). The Salaries Determination sets out provisions dealing with salary and the Allowances Determination sets out provisions dealing with salary related allowances for members of the Australian Defence Force (ADF).

The purpose of this Determination is to repeal Service allowance, Reserve allowance and Trainee allowance provided under the Allowances Determination and build these allowances into the salary rates provided under the Salaries Determination.

This Determination implements the first tranche of the ADF salaries and allowances modernisation program by building a number of allowances which recognise the unique nature of military service into the member's salary. The modernisation program has been established to modernise the ADF remuneration package to support better attraction and retention of the current and future ADF workforce for sustained capability.

Section 1 of this Determination sets out the manner in which this Determination may be cited.

Section 2 of this Determination provides that the Determination commences on 13 May 2021. To remove doubt, this Determination has effect **after** DFRT Determination No. 4 of 2021.

Section 3 provides that this instrument has authority under section 58H of the *Defence Act 1903*.

Section 4 provides that each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

Schedule 1 sets out amendments to DFRT Determination No. 2 of 2017

Section 1 omits and substitutes subsection B.3.5.1 of the Salaries Determination which provides the rate of salary payable to officer aviation specialists on the day they become an officer aviation specialist. The subsection is being amended to provide that an officer's aviation specialist salary is the rate equal to or higher than the rate payable on the day immediately before the member becomes an aviation specialist. The subsection has also been rewritten to remove the different calculations of salary payable to a member based on their rank and whether they are in the Permanent Force or the Reserves. These different calculations are no longer needed with the removal of Service allowance and Reserve allowance under Schedule 2 of this Determination.

Sections 2 to 16 omit and substitute the salary schedules provided under the Salaries Determination. The rates of salary provided for members under the schedules are being revised to build in a component to compensate for the removal of Service allowance, Reserve allowance or Trainee allowance which have been removed by Schedule 2 of this Determination. The revised salary rates also include a component of uniform allowance which was payable to members under Defence Determination 2016/19, *Conditions of service*, made under section 58B of the Act, before the commencement of this Determination.

Schedule 2 sets out amendments to DFRT Determination No. 11 of 2013

Section 1 amends section A.1.4 of the Allowances Determination to remove references to Trainee allowance, Service allowance and Reserve allowance which are being omitted by this Determination.

Sections 2, 3 and 4 omit Part B Divisions B.1, B.2 and B.11 from the Allowances Determination. These Divisions provided Trainee allowance, Service allowance and Reserve allowance, which are being rolled into the salary rates under Schedule 1 of this Determination.

Sections 5 and 6 amend sections B.12.10 and B.14.11 of the Allowances Determination which set out the interaction of allowances with Special Forces disability allowance and Clearance Diver allowance. These sections are being amended to remove the interaction provision between these allowances and Trainee allowance which has been omitted by section 2 of this Schedule.

Section 7 inserts a new Division D.3 into the Principal Determination. Section D.3.1 of the new Division provides that a person who was a member of the Reserves before 13 May 2021 and who completes the minimum period of eligible service between 13 May 2021 and 30 June 2022, may be eligible for a top up payment. By way of background, after Reserve allowance is rolled into a member's salary on 13 May 2021, a member may receive an amount of salary for time worked between 13 May 2021 and 30 June 2022 that is less than what they would have otherwise received had Reserve allowance remained in force. This section provides that if a member receives less salary than what they would have otherwise received is eligible for a payment of the difference between the amount of military salary they were paid and the amount of salary and Reserve allowance they would have received (had Reserve allowance remained in force) for time worked between 13 May 2021 and 30 June 2022.

Section 8 omits and substitutes table 1 of Part F of the Allowances Determination which provides the rates of the allowances under the Allowances Determination. The table has been amended to remove Trainee allowance, Service allowance and Reserve allowance which have been omitted by sections 2, 3 and 4 of this Schedule.

Schedule 3 sets out transitional provisions

Section 1 provides a transitional provision for members who are undertaking basic recruit training on 13 May 2021. The provision sets out that these members are to continue to receive the rate of salary and trainee allowance that was payable to under DFRT Determination DFRT Determination No. 4 of 2021, *ADF Workplace Remuneration Arrangement 2020-2023*, until the day they complete basic recruit training.

Criteria are provided for the exercise of discretions under the Principal Determination, as amended by this Determination. Adverse decisions may be subject to inquiry under the ADF redress of grievance system. A person may make a complaint to the Defence Force Ombudsman.

Consultation

Consultation was undertaken with the Minister for Defence, the Chiefs of Staff Committee, Navy, Army, Air Force, People Systems Business Analysis Branch, Defence Finance Group and Defence Tax Management Office before this Determination was made.

The rule maker was satisfied that further external consultation was not required.
