  - iii. Sub Lieutenant.
  - iv. Petty Officer.
  - v. Leading Seaman.
  - vi. Able Seaman.
  - vii. Chaplain Division 1.
  - viii. Chaplain Division 2.

#### **2 Paragraph D.2.3.2.b (Eligibility for payment – From 1 July 2020)**

Omit the paragraph, substitute:

- b. They hold one of the following ranks or are in one of the following divisions.
  - i. Lieutenant Commander.
  - ii. Lieutenant.
  - iii. Sub Lieutenant.
  - iv. Petty Officer.
  - v. Leading Seaman.
  - vi. Able Seaman.
  - vii. Chaplain Division 1.
  - viii. Chaplain Division 2.

## **Schedule 2—Transitional**

### **1 Application**

This schedule applies to a member who is a Chaplain and would have been eligible for the Navy retention incentive payment under Division D.2 of DFRT Determination No. 11 of 2013, between 1 July 2019 and the commencement of this Determination.

### **2 Benefit**

A member is eligible to receive a payment of \$20,000 on the day this determination commences.
