EXPLANATORY STATEMENT

Defence Force Remuneration Tribunal Determination No. 12 of 2021, ADF Workplace Remuneration Arrangement 2020–2023 (Star Rank senior officer variation)

This Determination made under section 58KD of the *Defence Act 1903* (the Act) amends Defence Force Remuneration Tribunal Determination No. 2 of 2017, *Salaries*, made under section 58H of the Act, and in accordance with subsection 33(3) of the *Acts Interpretation Act 1901* (AIA Act).

This Determination gives effect to the variation made to the ADF Workplace Remuneration Arrangement 2020-2023 (the Arrangement) for Star Rank senior officers. The Arrangement is an agreement reached between the Minister, acting on behalf of the Commonwealth, and the Chief of Defence Force, acting on behalf of the members of the Australian Defence Force (ADF).

Section 1 of this Determination sets out the manner in which this Determination may be cited.

Section 2 of this Determination provides that the Determination commences on 5 August 2021. To remove doubt, this Determination has effect **after** DFRT Determination No. 11 of 2021.

Section 3 provides that this instrument has authority under section 58KD of the Defence Act 1903.

Section 4 provides that each instrument made under section 58H of the Act that is specified in a Schedule to this instrument is amended as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

Schedule 1 sets out amendments to DFRT Determination No. 2 of 2017, *Salaries*. In accordance with the Arrangement as amended, a 1.7 per cent increase is applied across each of the salary schedules in this Determination. The following Schedules are substituted:

- Schedule B.1 (Senior officer salary rates)
- Schedule B.15 (Senior officer specialist salary rates medical officer)
- Schedule B.16 (Senior officer specialist salary rates dental officer)
- Schedule B.17 (Senior officer specialist salary rates legal officer)
- Schedule B.18 (Senior officer specialist salary rates Chaplain)

Criteria are provided for the exercise of discretions under the Principal Determination, as amended by this Determination. Adverse decisions may be subject to inquiry under the ADF redress of grievance system. A person may make a complaint to the Defence Force Ombudsman.
