EXPLANATORY STATEMENT

Defence Force Remuneration Tribunal Determination No. 18 of 2021, Salaries – Network technician amendments

This Determination amends Defence Force Remuneration Tribunal (DFRT) Determination No. 2 of 2017, Salaries (the Principal Determination), made under section 58H of the Defence Act 1903 (the Act) and in accordance with subsection 33(3) of the Acts Interpretation Act 1901 (AIA Act). The Principal Determination sets out provisions dealing with salary for members of the Australian Defence Force (ADF).

The purpose of this Determination is to make technical amendments that reinsert three employment categories under Part 3 of Schedule B.11 of the Principal Determination that were inadvertently omitted by Defence Force Remuneration Tribunal Determination No. 9 of 2020, Salaries – Air Force Employment Categories – amendment that commenced on 7 January 2021.

Technical amendments are routine in nature, and do not alter the underlying policy. These amendments will not change the benefits which are currently provided.

Section 1 of this Determination sets out the manner in which this Determination may be cited.

Section 2 of this Determination provides that the Determination commences on 7 January 2021. While the DFRT and ADF make every effort to avoid retrospective commencement dates, subsection 58H(8) of the Act, makes provision for retrospectivity as long as the instrument meets the criteria set out in that subsection. The ADF has confirmed that the instrument does meet those conditions.

Section 3 provides that this instrument has authority under section 58H of the Defence Act 1903.

Section 4 provides that each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

Schedule 1-Network technician amendments

Sections 1 to 3 amend the tables for pay grades 3 to 5 in Part 3 (Air Force) of Schedule B.11 (Other Rank pay grades) of the Principal Determination. The tables list the employment categories in Air Force that are paid at pay grades 3 to 5. The amendments update existing Air Force employment categories in order to reinsert three table items that were inadvertently removed by *Defence Force Remuneration Tribunal Determination No. 9 of 2020, Salaries – Air Force Employment Categories – amendment.* The tables are amended to insert 'Network Technician' Grades 1 and 2 into Pay Grades 3 and 4, and to insert 'Network Technician Advanced' into Pay Grade 5.
