# EXPLANATORY STATEMENT

## Defence Force Remuneration Tribunal Determination No. 19 of 2021, Salaries – ADF general duties employment categories – amendment

This Determination amends Defence Force Remuneration Tribunal (DFRT) Determination No. 2 of 2017, *Salaries* (the Principal Determination), made under section 58H of the *Defence Act 1903* (the Act) and in accordance with subsection 33(3) of the *Acts Interpretation Act 1901* (AIA Act). The Principal Determination sets out provisions dealing with salary for members of the Australian Defence Force (ADF).

The purpose of this Determination is to amend Schedule B.11 of the Principal Determination to provide a consistent general duties employment categories in the Graded Other Ranks Pay Structure for unskilled enlistees or recruits in Navy, Army and Air Force.

Section 1 of this Determination sets out the manner in which this Determination may be cited.

Section 2 of this Determination provides that the Determination commences on 9 December 2021.

Section 3 provides that this instrument has authority under section 58H of the *Defence Act 1903*.

Section 4 provides that each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

### Schedule 1 – ADF general duties employment categories

Sections 1 to 3 amend the tables which list the employment categories in Army, Navy and Air Force for Pay Grade 1 in Part 1 (Navy), Part 2 (Army) and Part 3 (Air Force) of Schedule B.11 (Other Rank pay grades) of the salaries Principal Determination. The tables are amended to omit 'General Experience' from Pay Grade 1 in Part 1 (Navy) and replace it with 'General mariner', to omit 'General Duties Airman' from Pay Grade 1 in Part 3 (Air Force) and replace it with 'General Enlisted Duties'. The Pay Grade 1 table in Part 2 (Army) has been amended to insert 'General Duties Soldier'.
