EXPLANATORY STATEMENT

Defence Force Remuneration Tribunal Determination No. 20 of 2021, Salaries – Construction Engineer employment categories – amendment

This Determination amends Defence Force Remuneration Tribunal (DFRT) Determination No. 2 of 2017, *Salaries* (the Principal Determination), made under section 58H of the *Defence Act 1903* (the Act) and in accordance with subsection 33(3) of the *Acts Interpretation Act 1901* (AIA Act). The Principal Determination sets out provisions dealing with salary for members of the Australian Defence Force (ADF).

The purpose of this Determination is to amend Schedules B.9 and B.11 of the Principal Determination to add, remove or rename employment categories that relate to Construction Engineers in Army and Air Force.

Section 1 of this Determination sets out the manner in which this Determination may be cited.

Section 2 of this Determination provides that the Determination commences on 20 January 2022.

Section 3 provides that this instrument has authority under section 58H of the *Defence Act 1903*.

Section 4 provides that each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

Schedule 1—Construction engineer employment categories amendments

Sections 1 to 4 amend the tables for Pay Grades 6 and 7 in Part 2 (Army) and Part 3 (Air Force) of Schedule B.9 (Warrant Officer pay grades) of the Principal Determination. The tables list the employment categories in Army and Air Force that are placed in Pay Grades 7 and 8. The amendments update existing Army and Air Force employment categories in order to implement reforms to the employment categories and remuneration structures of Construction Engineers in Army and Air Force. The tables are amended to omit 'Manager Works Tier A' from Pay Grade 6 in Part 2, and omit 'Works Manager Tier A' from Pay Grade 6 in Part 3. The tables are also amended to insert 'Manager Works Tier A' into Pay Grade 7 in Part 2, and insert 'Works Manager Tier A' into Pay Grade 7 in Part 3.

Sections 5 to 30 amend the tables for Pay Grades 3 to 7 in Part 2 (Army), and Pay Grades 5 to 7 (Air Force), of Schedule B.11 (Other Rank pay grades) of the Principal Determination. The tables list the employment categories in Army and Air Force that are placed in Pay Grades 3 to 7. The amendments update existing Army and Air Force employment categories in order to implement reforms to the employment categories and remuneration structures of Construction Engineers in Army. The tables are amended to make various changes to Army employment categories to Pay Grades 3 to 7 in Part 2. The tables are also amended to omit 'Supervisor Trades' from Pay Grade 5, and to omit 'Manager Trades' and 'Works Manager' from Pay Grade 6 in Part 3, and to insert 'Supervisor Trades' into Pay Grade 6 and 'Manager Trades' and 'Works Manager' into Pay Grade 7 in Part 3.
