## **EXPLANATORY STATEMENT**

# Defence Force Remuneration Tribunal Determination No. 23 of 2021, ADF Workplace Remuneration Arrangement (non-Senior Officer) 2020–2023, Service Warrant Officer – amendment

This Determination made under section 58KD of the *Defence Act 1903* (the Act) amends Defence Force Remuneration Tribunal Determination No. 2 of 2017, *Salaries*, made under section 58H of the Act, and in accordance with subsection 33(3) of the *Acts Interpretation Act 1901* (AIA Act).

This Determination gives effect to the variation made to the ADF Workplace Remuneration Arrangement 2020-2023 (the Arrangement) for Service Warrant Officers (Reserves) who were inadvertently overlooked in the making of DFRT Determination No. 17 of 2021. Section 7 of that Determination inadvertently removed Part 1A of Schedule B.10 which provided the daily rate of salary for Service Warrant Officers who are members of the Reserves. This Determination reinserts Part 1A of Schedule B.10 in the Principal Determination.

Section 1 of this Determination sets out the manner in which this Determination may be cited.

Section 2 of this Determination provides that the Determination commences on 11 November 2021. While the DFRT and ADF make every effort to avoid retrospective commencement dates, subsection 58H(8) of the Act, makes provision for retrospectivity as long as the instrument meets the criteria set out in that subsection. The ADF has confirmed that the instrument does meet those conditions.

Section 3 provides that this instrument has authority under section 58KD of the *Defence Act* 1903.

Section 4 provides that each instrument made under section 58H of the Act that is specified in a Schedule to this instrument is amended as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

Schedule 1 sets out amendments to Schedule B.10 of the Principal Determination. Section 1 reinserts Part 1A into Schedule B.10 which provides the daily rate of salary for Service Warrant Officers who are members of the Reserves. This rate includes the second general wage increase as provided under the Arrangement.

Criteria are provided for the exercise of discretions under the Principal Determination, as amended by this Determination. Adverse decisions may be subject to inquiry under the ADF redress of grievance system. A person may make a complaint to the Defence Force Ombudsman.
