# **EXPLANATORY STATEMENT**

# Defence Force Remuneration Tribunal Determination No. 2 of 2022, Salaries – Senior Officer Graded Structure – amendment

This Determination amends Defence Force Remuneration Tribunal (DFRT) Determination No. 2 of 2017, Salaries (the Principal Determination), made under section 58H of the Defence Act 1903 (the Act) and in accordance with subsection 33(3) of the Acts Interpretation Act 1901 (AIA Act). The Principal Determination sets out provisions dealing with salary for members of the Australian Defence Force (ADF).

The purpose of this Determination is to remove the pay grade construct from the Senior Officer Graded Structure and replace with one set of salary rates for each rank.

Section 1 of this Determination sets out the manner in which this Determination may be cited.

Section 2 of this Determination provides that the Determination commences on 4 August 2022.

Section 3 provides that this instrument has authority under section 58H of the Defence Act 1903.

Section 4 provides that each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

#### Schedule 1—Senior Officer Graded Structure amendments

Section 1 omits the exception in the definition of 'pay grade' in section A.1.9 of the Principal Determination. The exception refers to the pay grade structure in section B.1.3 of the Principal Determination, which is omitted by section 2 of this Schedule.

Section 2 omits section B.1.3 of the Principal Determination which sets out the placement rules governing the Senior Officer Graded Structure. The disestablishment of the pay grade construct makes these rules redundant and inoperable. These rules are omitted.

Section 3 omits paragraph B.1.4.c of the Principal Determination which provides that a senior officer is to be paid the rate of salary in Schedule B.1 that corresponds to the senior officer's pay grade. The paragraph is omitted as the pay grades to which the paragraph refers no longer exist, as a result of sections 2, 4 and 5 of this Schedule.

Sections 4 and 5 omit and substitute Parts 1 and 2 of Schedule B.1 of the Principal Determination which provided the rates of salary for the relevant pay grade and rank (BRIG-GEN). The new tables provide a rate of salary for each increment in each rank.
