EXPLANATORY STATEMENT

Defence Force Remuneration Tribunal Determination No. 7 of 2022, Salaries – Navy Boatswains Mate – amendments

This Determination amends Defence Force Remuneration Tribunal (DFRT) Determination No. 2 of 2017, Salaries (the Principal Determination), made under section 58H of the Defence Act 1903 (the Act) and in accordance with subsection 33(3) of the Acts Interpretation Act 1901 (AIA Act). The Principal Determination sets out provisions dealing with salary for members of the Australian Defence Force (ADF).

The purpose of this Determination is to amend Schedule B.11 of the Principal Determination to insert several new pay grades for the Boatswains Mate employment category. In response to an increasingly complex working environment, the Boatswains Mate employment category has evolved from a generalist workgroup with specialist skills to a specialist workgroup with significantly enhanced responsibilities and accountabilities, which has required them to elevate their skills and knowledge. Navy has identified an increased work value for this part of the workforce and is inserting new Boatswains Mate employment categories to reflect the changes to the work and operating environment.

Section 1 of this Determination sets out the manner in which this Determination may be cited.

Section 2 of this Determination provides that the Determination commences on 7 October 2022.

Section 3 provides that this instrument has authority under section 58H of the Defence Act 1903.

Section 4 provides that each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

Schedule 1-Navy Boatswains Mate amendments

Sections 1 to 3 amend the tables for Pay Grades 3 and 4 in Part 1 (Navy) of Schedule B.11 (Other rank pay grades) of the Principal Determination. The tables list the employment categories in Navy that are paid at Pay Grades 3 and 4. The amendments update existing Navy employment categories in order to implement reforms to the employment categories and remuneration structure of Boatswains Mates. The employment categories are amended to insert 'Leading Seaman Boatswains Mate — Landing Helicopter Deck Landing Craft' and 'Leading Seaman Boatswains Mate — Shipborne Lifesaving Survival Equipment Maintainer and Industrial Sewing Machine and Material Manufacturing' into Pay Grade 4 and to insert 'Chief Petty Officer Boatswain — Limited Navigation Watchkeeping Certificate Qualification' and 'Petty Officer Boatswain — Limited Navigation Watchkeeping Certificate Qualification' into Pay Grade 5.
