### **EXPLANATORY STATEMENT**

## Defence Force Remuneration Tribunal Determination No. 1 of 2022, Salaries – Scientific Officers – amendments

This Determination amends Defence Force Remuneration Tribunal (DFRT) Determination No. 2 of 2017, Salaries (the Principal Determination), made under section 58H of the Defence Act 1903 (the Act) and in accordance with subsection 33(3) of the Acts Interpretation Act 1901 (AIA Act). The Principal Determination sets out provisions dealing with salary for members of the Australian Defence Force (ADF).

The purpose of this Determination is to make technical amendments that omit and substitute 6 employment categories under Part 4 of Schedule B.2 of the Principal Determination that were inadvertently omitted and substituted by *Defence Force Remuneration Tribunal Determination No. 2 of 2021, Salaries – Air Intelligence Officer Employment Category – amendment* that commenced on 7 January 2021.

Technical amendments are routine in nature, and do not alter the underlying policy. These amendments will not change the benefits which are currently provided.

Section 1 of this Determination sets out the manner in which this Determination may be cited.

Section 2 of this Determination provides that the Determination commences on 3 March 2022.

Section 3 provides that this instrument has authority under section 58H of the Defence Act 1903.

Section 4 provides that each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

#### Schedule 1-Scientific Officers amendments

Sections 1 to 11 amend the tables for Pay Grades 2 to 5 and 8 in Part 4 (Air Force) of Schedule B.2 (Officer Pay Grades) of the Principal Determination. The tables list the employment categories in Air Force that are paid at Pay Grades 2 to 5 and 8. The amendments update existing Air Force employment categories that were inadvertently reverted to previous names by *Defence Force Remuneration Tribunal Determination No. 2 of 2021, Salaries – Air Intelligence Officer Employment Category – amendment.* These sections remove the former names and reinstate the current and correct names: omit 'Laboratory' Grades 1 to 3 from Pay Grades 2 to 4, omit 'Laboratory Grade 2' Command Level 1 from Pay Grade 4, and omit 'Laboratory Grade 3' Command Levels 1 and 2 from Pay Grades 5 and 8; the amendments then insert 'Scientific Officer' Grades 1 to 3 into Pay Grades 2 to 4, insert 'Scientific Officer Grade 2' Command Level 1 into Pay Grade 4, and insert 'Scientific Officer Grade 3' Command Levels 1 and 2 into Pay Grades 5 and 8.
