EXPLANATORY STATEMENT

Defence Force Remuneration Tribunal Determination No. 10 of 2023, ADF allowances – Clearance divers – amendment

This Determination amends Defence Force Remuneration Tribunal (DFRT) Determination No. 11 of 2013, ADF allowances (the Principal Determination), made under section 58H of the *Defence Act 1903* (the Act) and in accordance with subsection 33(3) of the *Acts Interpretation Act 1901* (AIA Act). The Principal Determination sets out provisions dealing with salary for members of the Australian Defence Force (ADF).

The purpose of this Determination is to amend the Principal Determination to provide the annual and daily rate of clearance diver allowance for members posted to a position in RAN diving school or as a Defence Explosive Ordnances Training School Instructor.

Section 1 of this Determination sets out the manner in which this Determination may be cited.

Section 2 of this Determination provides that the Determination commences on date of signature.

Section 3 provides that this instrument has authority under section 58H of the Defence Act 1903.

Section 4 provides that each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

Schedule 1—Clearance divers – amendment

Section 1 repeals and substitute the table in section B.14.7 of the Principal Determination which provides the annual rate of clearance diver allowance. The table has been amended to provide the annual rate of clearance diver allowance for a member posted to RAN diving school or a Defence Explosive Ordnances Training School as an instructor.

Section 2 repeals and substitute the table in subsection B.14.8.1 of the Principal Determination which provides the daily rate of clearance diver allowance. The table has been amended to provide the daily rate of clearance diver allowance for a member posted to RAN diving school or a Defence Explosive Ordnances Training School as an instructor.

Sections 3 to 5 amends table 1 of Part F of the Principal Determination which provides rates for the allowances which are payable under the Principal Determination. Table 1 has been amended as following.

- Sections 3 and 4 amend table items 41 and 50 to update cross references as a consequence of the changes made by sections 1 and 2 of this Determination.
- Section 5 inserts table items 86 and 87 to provide the annual and daily rate of clearance diver allowance that applies to a member posted to a posted to RAN diving school or a Defence Explosive Ordnances Training School as an instructor.

Authority: Section 58H of the Defence Act 1903
