# EXPLANATORY STATEMENT

## Defence Force Remuneration Tribunal No. 11 of 2023, Salaries – ADF Construction Engineer employment categories – amendment

This Determination amends Defence Force Remuneration Tribunal (DFRT) Determination No. 2 of 2017, Salaries (the Principal Determination), made under section 58H of the *Defence Act 1903* (the Act) and in accordance with subsection 33(3) of the *Acts Interpretation Act 1901* (AIA Act). The Principal Determination sets out provisions dealing with salary for members of the Australian Defence Force (ADF).

The purpose of this Determination is to amend Schedule B.9 of the Principal Determination to include the Supervisor Works and Manager Trades employment categories for Warrant Officer Class 1 (Equivalent) in order to promote members within the construction trade continuum.

Section 1 of this Determination sets out the manner in which this Determination may be cited.

Section 2 of this Determination provides that the Determination commences on date of signature.

Section 3 provides that this instrument has authority under section 58H of the *Defence Act 1903*.

Section 4 provides that each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

### Schedule 1—ADF Construction Engineer employment categories – amendment.

Section 1 amends Schedule B.9 Part 2 Pay grade 7 of the Principal Determination which provides the employment categories for Warrant Officer Class 1 in the Army. The section inserts the employment category of 'Supervisor Works Tier A' into Pay grade 7.

Section 2 amends Schedule B.9 Part 3 Pay grade 7 of the Principal Determination which provides the employment categories for Warrant Officer Class 1 (Equivalent) in the Air Force. The section inserts the employment category of 'Manager Trades Tier A' into Pay grade 7.
