#### **EXPLANATORY STATEMENT**

## Defence Force Remuneration Tribunal Determination No. 13 of 2023, Salaries – Cyber Warfare Employment Categories – amendment

This Determination amends Defence Force Remuneration Tribunal (DFRT) Determination No. 2 of 2017, Salaries (the Principal Determination), made under section 58H of the *Defence Act 1903* (the Act) and in accordance with subsection 33(3) of the *Acts Interpretation Act 1901* (AIA Act). The Principal Determination sets out provisions dealing with salary for members of the Australian Defence Force (ADF).

The purpose of this Determination is to amend employment categories under Schedule B.2, B.9 and B.11 of the Principal Determination to amend the title of the various cyber warfare related employment categories to either Cyber Warfare Officer or Cyber Warfare Specialist.

Section 1 of this Determination sets out the manner in which this Determination may be cited.

Section 2 of this Determination provides that the Determination commences on the day after signature.

Section 3 provides that this instrument has authority under section 58H of the Defence Act 1903.

Section 4 provides that each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

Schedule 1 – Cyber Warfare employment categories amendment.

Sections 1 to 10 amend items in Part 4: Air Force of Schedule B.2 (Officer pay grades) of the Principal Determination. The table sets out the rate of salary for a member on becoming an officer. The amendments are administrative in nature and change the name of the Cyberspace Warfare Officer to Cyber Warfare Officer.

Sections 11 to 17 amend items in Schedule B.9 (Warrant Officer Class 1 pay grades) of the Principal Determination. The table sets out the rate of salary for a member on becoming a Warrant Officer Class 1. The amendments are administrative in nature and change the name of the various cyber employment categories to Cyber Warfare Specialist.

Sections 18 to 35 amend items in Schedule b.11 (Other rank pay grades) of the Principal Determination. The table sets out the rate of salary for a member for the employment category. The amendments are administrative in nature and change the name of the various cyber employment categories to Cyber Warfare Specialist.

**Authority:** Section 58H of the Defence Act 1903
