EXPLANATORY STATEMENT

Defence Force Remuneration Tribunal Determination No. 14 of 2023, Salaries – Executive vehicle allowance – amendment

This Determination amends Defence Force Remuneration Tribunal (DFRT) Determination No. 2 of 2017, Salaries (the Principal Determination), made under section 58H of the *Defence Act 1903* (the Act) and in accordance with subsection 33(3) of the *Acts Interpretation Act 1901* (AIA Act). The Principal Determination sets out provisions dealing with salary for members of the Australian Defence Force (ADF).

The purpose of this Determination is to roll executive vehicle allowance in to senior officer salary rates which are provided by Schedules B.1 and B.15 to B.18 of the Principal Determination.

Section 1 of this Determination sets out the manner in which this Determination may be cited.

Section 2 of this Determination provides that the Determination commences on 9 November 2023.

Section 3 provides that this instrument has authority under section 58H of the Defence Act 1903.

Section 4 provides that each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

Schedule 1 - Executive vehicle allowance amendment

Sections 1 to 5 amend various Schedules of the Principal Determination which provide the salary rate for a member who is a senior officer in either the Reserves or the Permanent Forces. The salary rates have been adjusted to include executive vehicle allowance, which now forms part of the salary payable to a senior officer. The following Schedules have been amended:

- Schedule B.1, which provides senior officer salary rates.
- Schedule B.15, which provides senior officer salary rates for medical officers.
- Schedule B.16, which provides senior officer salary rates for dental officers.
- Schedule B.17, which provides senior officer salary rates for legal officers.
- Schedule B.18, which provides senior officer salary rates for Chaplains and Maritime Spiritual Wellbeing Officers.

Authority: Section 58H of the *Defence Act 1903*
