EXPLANATORY STATEMENT

Defence Force Remuneration Tribunal No. 10 of 2024, Salaries – Royal Australian Artillery Employment Categories

This Determination amends Defence Force Remuneration Tribunal (DFRT) Determination No. 2 of 2017, Salaries (the Principal Determination), made under section 58H of the *Defence Act 1903* (the Act) and in accordance with subsection 33(3) of the *Acts Interpretation Act 1901* (AIA Act). The Principal Determination sets out provisions dealing with salary for members of the Australian Defence Force.

The purpose of this Determination is to amend employment categories under Schedule B.9 and Schedule B.11 of the Principal Determination to reflect changes made by the restructure of the Royal Australian Artillery.

Section 1 of this Determination sets out the manner in which this Determination may be cited.

Section 2 of this Determination provides that the Determination commences on 5 December 2024.

Section 3 provides that this instrument has authority under section 58H of the Defence Act 1903.

Section 4 provides that each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

Schedule 1 - Royal Australian Artillery employment categories amendment

Sections 1 to 10 amend the tables for pay grades 5 to 8 in Part 2 (Army) of Schedule B.9 (Warrant Officer Class 1 pay grades) of the Principal Determination. The tables list the employment categories for Warrant Officers Class 1 in the Army that are paid at the respective pay grade. The tables are being amended to update the employment categories involved with the Royal Australian Artillery restructure.

Sections 11 to 36 amend the tables for pay grades 1 to 6 in Part 2 (Army) of Schedule B.11 (Other Rank pay grades) of the Principal Determination. The tables list the employment categories for other ranks in the Army that are paid at the respective pay grade. The tables are being amended to update the employment categories involved with the Royal Australian Artillery restructure.
