#### C.1.5 Transition – Navy non-nuclear submariner employment categories

- 1. This section applies to a member who meets all of the following.
  - a. The member transfers into one of the following employment categories.
    - i. Electronics Technician Fire Control Submariner.
    - ii. Electronics Technician Navigation Submariner.
    - iii. Hospitality Specialist Submariner.
    - iv. Information Systems Communications Submariner.
    - v. Information Systems Technician Electronic Warfare Submariner.
    - vi. Machinist's Mate Auxiliary Submariner.
    - vii. Machinist's Mate Weapons Submariner.
    - viii. Sonar Technician Submariner.
  - b. The rate of salary for the member's employment category is lower than the rate of salary payable for their previous employment category under Part B Division 4 or Division 5.
- 2. Despite Part B, the member is paid the rate of salary payable immediately before they transferred, as varied by subsection 3, from the day the transfer takes effect.
- 3. The member's rate of salary is adjusted by both of the following.
  - a. An advance in increment under Defence Determination 2016/19, *Conditions of service*, Chapter 3 Part 2 Division 3.
  - b. An ADF Workplace Remuneration Arrangement general salary adjustment determined by the DFRT.
- 4. This section ceases to apply to a member on the day the rate of salary payable to the member under subsection 2 is lower than the rate of salary that would be payable to the member under Part B, had this section not applied.

**Note:** If the member ceases to be in an employment category listed in paragraph 1.a they no longer meet the conditions of this section and it ceases to apply.

## **EXPLANATORY STATEMENT**

# Defence Force Remuneration Tribunal No. 9 of 2024, Salaries – Nuclear submarine employment categories – amendment

This Determination amends Defence Force Remuneration Tribunal (DFRT) Determination No. 2 of 2017, Salaries (the Principal Determination), made under section 58H of the *Defence Act 1903* (the Act) and in accordance with subsection 33(3) of the *Acts Interpretation Act 1901* (AIA Act). The Principal Determination sets out provisions dealing with salary for members of the Australian Defence Force (ADF).

The purpose of this Determination is to introduce 8 new submariner employment categories for submariners who are not required to hold a nuclear qualification but will work on nuclear powered submarines.

Section 1 of this Determination sets out the manner in which this Determination may be cited.

Section 2 of this Determination provides that the Determination commences on 1 December 2024.

Section 3 provides that this instrument has authority under section 58H of the Defence Act 1903.

Section 4 provides that each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

#### Schedule 1 - Non-nuclear submarine workforce

Item 1 inserts a new section C.1.5 into the Principal Determination which provides a transitional provision for members who transition into a Navy non-nuclear submariner employment category. The purpose of this section is to provide salary non-reduction for a member who transfers to a non-nuclear qualified submariner employment category if their pay grade before their transfer is higher than that of the level of the non-nuclear submariner employment category. This section ceases to apply when the member's salary that has been preserved is lower than that payable for their non-nuclear submariner employment category.

Items 2 to 4 amend Part 2 of Schedule B.9 of the Principal Determination which provides the Navy employment categories for Warrant Officers Class 1. The Schedule has been amended in the following ways.

- To insert the new employment category of Hospitality Specialist SM into pay grade 7.
- To insert the new employment category of Sonar Technician SM into pay grade 8.
- To insert the following new employment categories into pay grade 9.
  - Electronics Technician Fire Control SM.
  - Electronics Technician Navigation SM.
  - Information Systems Technician Communications SM.
  - Information Systems Technician Electronic Warfare SM.
  - Machinist's Mate Auxiliary SM.
  - Machinist's Mate Weapons SM.

Items 5 to 15 amend Part 1 of Schedule B.11 of the Principal Determination which provides the Navy employment categories for other rank members. This schedule has been amended to insert the following new employment categories into pay grades 2, 3, 6, 7, 8 and 9.

- Electronics Technician Fire Control SM.
- Electronics Technician Navigation SM.
- Hospitality Specialist SM.
- Information Systems Technician Communications SM.
- Information Systems Technician Electronic Warfare SM.
- Machinist's Mate Auxiliary SM.
- Machinist's Mate Weapons SM.
- Sonar Technician SM.
