EXPLANATORY STATEMENT

Defence Force Remuneration Tribunal Determination No. 12 of 2024, Salaries – Air Force Security Forces – amendment

This Determination amends Defence Force Remuneration Tribunal (DFRT) Determination No. 2 of 2017, Salaries (the Principal Determination), made under section 58H of the *Defence Act 1903* (the Act) and in accordance with subsection 33(3) of the *Acts Interpretation Act 1901* (AIA Act). The Principal Determination sets out provisions dealing with salary for members of the Australian Defence Force (ADF).

The purpose of this Determination is to amend the employment categories under Schedule B.9 and B.11 of the Principal Determination to amend Security Forces employment categories to reflect the organisational restructure of the Air Force's Security Forces.

Section 1 of this Determination sets out the manner in which this Determination may be cited.

Section 2 of this Determination provides that the Determination commences on 5 December 2024.

Section 3 provides that this instrument has authority under section 58H of the *Defence Act 1903*.

Section 4 provides that each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

Schedule 1 – Air Force Security Forces other rank amendments

Items 1 to 12 amend pay grades 3 to 8 in Part 3 (Air Force) of Schedule B.9 (Warrant Officer Class 1 pay grades) of the Principal Determination. The tables list the employment categories for Warrant Officers Class 1 in the Air Force that are paid at the respective pay grade. The tables are being amended in line with the amended employment category titles as part of the organisational restructure of the Air Force's Security Forces.

Items 13 to 27 amend pay grades 1 to 6 in Part 3 (Air Force) of Schedule B.11 (Other Rank pay grades) of the Principal Determination. The tables list the employment categories for other ranks in the Air Force that are paid at the respective pay grade. The tables are being amended in line with the amended employment category titles as part of the organisational restructure of the Air Force's Security Forces.
