#### **EXPLANATORY STATEMENT**

## Defence Force Remuneration Tribunal Determination No. 2 of 2025, Salaries – Army Aviation – Restructure of Employment Categories – amendment

This Determination amends Defence Force Remuneration Tribunal (DFRT) Determination No. 2 of 2017, Salaries (the Principal Determination), made under section 58H of the *Defence Act 1903* (the Act) and in accordance with subsection 33(3) of the *Acts Interpretation Act 1901* (AIA Act). The Principal Determination sets out provisions dealing with salary for members of the Australian Defence Force (ADF).

The purpose of this Determination is to amend the employment categories within the Australian Army Aviation Corps and the Royal Australian Corps of Electrical and Mechanical Engineers under Schedules B.9 and B.11 of the Principal Determination. This follows a holistic capability review of the Army Aviation capability and a resultant restructure of the associated employment categories.

Section 1 of this Determination sets out the manner in which this Determination may be cited.

Section 2 of this Determination provides that the Determination commences on 8 May 2025.

Section 3 provides that this instrument has authority under section 58H of the Defence Act 1903.

Section 4 provides that each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

#### Schedule – Army Aviation Employment Categories amendments

Items 1 to 10 amend pay grades 6 to 8 in Part 2 (Army) of Schedule B.9 (Warrant Officer Class 1 pay grades) of the Principal Determination. The tables list the employment categories for Warrant Officers Class 1 in the Army that are paid at the respective pay grade. The tables are being amended in line with the amended employment category titles and pay grades as part of the organisational restructure of the Army Aviation capability.

Items 11 to 32 amend pay grades 2 to 8 in Part 2 (Army) of Schedule B.11 (Other Rank pay grades) of the Principal Determination. The tables list the employment categories for other ranks in the Army that are paid at the respective pay grade. The tables are being amended in line with the amended employment category titles and pay grades as part of the organisational restructure of the Army Aviation capability.
